4. That the Deponent-1 _____ (name of the student) is neither pursuing nor shall pursue any other course as well as undertakes not to engage himself/ herself in any job after his/her admission to the GLA University until registration for completion of the said course work.
5. That we (both the Deponents) have received copies of the Prospectus of the University as well as the Rules and Regulations of the Hostels of the University. We (both the Deponents) have read & understood and have been explained thoroughly all the information contained in them and undertake to abide by them in letter and spirit.
6. That the Deponent-1 _____ (name of the student) shall not involve any time in any disciplinary act; else, he/ she will be liable for punishment including expulsion/ rustication as per the Ordinances of the University in force and that shall be binding on us.
7. The Deponent-1 _____ (Name of the student), hereby accepts and agree to abide by the following disciplinary actions in the event of cheating, dishonesty, or malpractice during any campus recruitment drive: First, an immediate suspension from the University for a duration of one semester will be imposed. Additionally, the student will be prohibited from participating in all future campus recruitment drives conducted by the University. Lastly, any Letter of intent (LOI) issued through campus recruitment will be cancelled.
8. The Deponent-1 _____ (Name of the student), hereby acknowledges that any involvement in cybercrime activities or possession of equipment intended for such purposes will result in immediate disciplinary action by the University, including expulsion and mandatory reporting to law enforcement authorities for legal prosecution. These actions are final, binding, and non-negotiable, reflecting the University's zero-tolerance policy toward such misconduct.

That the Deponent-1 _____ (name of the student) will attend all theory, tutorial, laboratory classes and will maintain attendance above 75% in each subject in every semester/ trimester in order to be able to appear in the examinations as per the Ordinances of the University in force and that shall be binding on us. We are fully aware that the attendance will be given only to the registered students for the semester/ trimester.
10. That we (both the Deponents) shall verify on our own the status of attendance and the performance of the Deponent-1 _____ (name of the student). If we (both the Deponents) find any anomaly, we (both the Deponents) shall contact the concerned teacher/ Head of the Department/ Director and get it corrected, if incorrect.
11. That we (both the Deponents) hereby undertake to pay the fee as per the fee structure _____ regularly each year during the course of studies of the Deponent-1 _____ (name of the student) by the date specified by the University. We are fully aware that, if fee is not paid by date of registration, the student will not be treated as registered and a late fee @ Rs. 100/- per day will be levied for first 10 days of the semester/ 7 days of the trimester and thereafter, the registration will be done only with a late fee of Rs. 2,000/- (Rs. Two Thousand only); the time limit for it being fifteen days after the start of the semester/ ten days after the start of the trimester. Thereafter, the registration shall stand closed for the semester/ trimester.
12. That the Deponent-1 _____ (name of the student) shall maintain good behavior and conduct. He/ she shall abide by all the provisions of the Ordinance pertaining to discipline and conduct of the students.
